RIVERTON BOARD OF EDUCATION MINUTES OF APRIL 27, 2021 REGULAR MEETING

The regular meeting of the Riverton Board of Education was called to order by Mr. Croft at 7:00 p.m. in the Media Center at the school.

PUBLIC LOTTERY FOR PRESCHOOL:

Mrs. Eck explained that the first seven numbers will be offered enrollment and the last two will be on a waiting list. The public lottery was closed at 7:03.

She reported that the increase in hours for the Social Worker and Media Specialist will support the full K-8 program. Mrs. Eck stated the increases in the budget are due to salary and benefit increases for the additional staff and the cost of tuition. Mr. Vrettos followed with a review of enrollment, revenues, grants, and appropriations.

Mr. Croft closed the Public Hearing at 7:10 upon no further discussion about the budget.

Included in budget line 620, Budgeted Withdrawal from Capital Reserve – Excess Costs & Other Capital Projects, is \$315,572 for other capital projects costs to replace sections of the school roof. The total cost of this project is \$316,000 which represents expenditures for construction elements.
